Minutes of the Meeting of Freckenham Parish Council on Monday 14th November 2022 at 7.30 pm at Freckenham Village Hall

<u>Present: Cllr Cornell, Cllr Englebrecht and Cllr Tucker</u> In attendance: Parish Council Clerk, Jadi Coe, and three members of the public

Cllr Cornell welcomed everyone to the meeting.

22/11/01 Apologies for absence & approval of reasons tendered

Two parishioners had given their apologies.

Two members of the public in attendance informed the members of their plans to change the use of a parcel of land in the village to a secure dog field. The land they are looking at is on Fordham Road, where they plan to erect an enclosed dog park with a 6ft fence, for dogs to socialise during day light hours when booked via an online booking system. Parking and dog bins would be available.

Cllr Harvey suggested a pre-assessment meeting with West Suffolk Planners to discuss their plans including access from the highway

The Parish Council commented that this was a good idea and would support the proposals based on what was discussed.

Cllr Stanbury reported on the shortfall in the County Council's draft budget for 2023/24 and his attendance at the recent public police meeting, in which speeding was the main concern of residents.

Cllr Harvey reported on the upcoming Town and Parish Forum and the issue of rough sleepers in the area.

<u>DC/22/1827/LB</u> – one internal double door between garage kitchen with blocking up of an existing door at The Old Rectory, Church Lane, Freckenham

<u>DC/22/1073/FUL</u> – conversion of barns to two dwellings, change of use of agricultural land to residential garden and associated external works at Hall Farm Church Lane, Freckenham – pending at 7/11

8.3 Sunnica Proposal including request for further financial help

The landscape consultant Michelle Bolger needs to carry out some further work due to changes in the application by Sunnica. The Sunnica alliance group are asking parishes for a further £1,500 to cover the cost of this work.

In the 2022/23 budget £4,800 was included for Sunnica expenses, at date £2,367.75 has already been paid to Michelle Bolger for works, so there are sufficient funds left to contribute a further £1,500.

It was proposed and agreed to fund a further £1,500 for any work required.

On Friday the clerk submitted the written representation.

Cllr Harvey reported that the Local Impact report and Written Representation should have now been submitted ahead of the open hearings which begin on 6th December at the Memorial Hall in Newmarket. If people wish to speak or attend then the must register, although people can observe the hearings remotely without registering.
